Dear Mrs. Leilua;

Thank you for your reply in support of our serious concerns regarding the breach of human rights of New Zealand citizens. We are a voice for a growing number of New Zealanders. Not only those who have officially signed our Declaration in support of human rights, full informed consent and freedom of choice but also for the majority of New Zealanders who are either too afraid or misinformed. Meanwhile we have been alternatively ignored or attacked by our registration body and the mainstream media for daring to speak publicly.

We agree that the measures taken by the current Government are unprecedented and a breach of human rights on many levels either directly or by implication, which is even worse, since many individuals are allowed to think that they are obligated to act in a certain way while the Government denies any coercion but fails to inform New Zealanders properly. The Government have unleashed a massive propaganda campaign to keep people in fear and thinking that the only solution to the alleged danger is the mass injections of an experimental novel gene therapy vector.

We are in complete agreement on the need for full informed consent and transparency. We already sent the following letter to the Government on 14<sup>th</sup> June 2021. See <https://nzdsos.com/wp-content/uploads/2021/07/TRUE-INFORMED-CONSENT-FOR-PFIZER-COMIRNATY-COVID-19-VACCINATION.pdf>

Regrettably the webpage linked into your response: *Covid-19 vaccine and human rights* <https://www.hrc.co.nz/enquiries-and-complaints/faqs/covid-19-vaccine-and-human-rights/> is mostly devoid of any information about the real nature and risks of these injections that are promoted as a vaccine but do not fit the usual definition of one.

We are unequivocally stating that Medsafe and the Government has been less than transparent and are withholding information about these novel genetic therapy agents, including the unprecedented level of adverse effects, including death. We have already provided this information to the Government and they have yet to acknowledge it and reply as to what they intend to do to address the situation.

Another critical deficiency in the information provided by the New Zealand Government is the withholding of published peer-reviewed scientific evidence proving that SARS-CoV-2, thus COVID-19, has a very low Infection Fatality Rate (IFR) of around 0.15%, which is similar to seasonal influenza of 0.1%. and that there

are also very effective treatments for this condition, further reducing morbidity, if correctly applied. Despite our best efforts, this Government has refused to allow or support such treatments while focusing exclusively their efforts on the mass injections.

This information alone, not only undermines the alleged need for all the drastic measures including lock downs, but also demonstrates an intent to maintain a state of fear in order to extract obedience from an uninformed population.

We therefore ask the NZ Human Rights Commission to amend the information provided on its own website to include this very important information and to take definitive steps to ensure full transparency from this Government.

It should be noted that we have already raised these issues with the Medsafe, key ministers and the Prime Minister herself. On the 21<sup>st</sup> of June 2021 we have also replied to their earlier dismissal of our valid concerns with a detailed and evidence-based response, to which no further response has been forthcoming. Can you please let us know what steps the NZ Human Rights Commission has taken and will take to hold the Government and other duty bearers to account to ensure that any measures now in place are proportionate and safeguard Te Tiriti o Waitangi and human rights. Please advise urgently how true Informed Consent that discusses the risks, benefits, uncertainties and alternatives is to be provided to the population of New Zealand. We are happy to provide further evidence, as needed.

Finally, due to the unprecedented nature of the breach of human rights in New Zealand, we believe that the direct involvement of the Chief Human Rights Commissioner, Mr. Paul Hunt is warranted. Therefore we would appreciate a direct response from the Chief Commissioner as soon as possible.

Looking forward to your ongoing support for full transparency on the COVID-19 Pandemic.
