Dear Colleagues,

Please find attached the latest Citizen's Database of deaths, temporally related to receiving the covid vaccination. We have *not* been involved in collecting and collating the information although we fully support the initiative, and continue to call for an honest and much-heightened pharmacovigilance approach to these tragedies. These deaths range in likelihood from 'almost certainly' to 'probably' related to the vaccine in our view, and there is a list of many hundreds more 'possibles' that are awaiting more information.

There is a literal avalanche of serious injuries being reported too, particularly cardiac-related, and we attach a redacted version of this database also. The truths, shortly to be made more reliably public, are flooding in, and it is bizarre, and mathematically impossible, for the government to claim just a single death so far.

As we have already been hearing and telling you for months, and you will soon be seeing too, the short term immediate harm from the vaccines is far worse than you are all admitting. So, why on earth would people trust any bland assurances about the completely unknown medium to long term risks?

As per our previous database reports to you, dated August 13th and 30th, and October 19th, the latter two unanswered, you will note again that the list contains the names of the dead New

Zealanders to enable your own investigations. We ask that this information be treated in utmost confidence of course, and used only to enable a thorough assessment of vaccine safety, which must be done urgently and be made publicly available, if a properly informed public is still desired.

We request your timely response and plan for assessing this much larger mortality list than has made it to, and through, the CARM process which remains opaque and plagued by many unanswered questions, and some confused and contradictory answers to OIA requests.

Our assessment of emerging data from research, and evidence released by public health authorities themselves, continues to undermine the 'safe and effective' narrative. This narrative must therefore be about objectives completely unrelated to the health and happiness of Kiwis. It seems not just our freedoms from death and physical injury are at stake but our other very basic freedoms too – of movement, speech, association, to non-discriminating healthcare, education and economic opportunities, and even to general participation in society.

As you preside over the inhumane rending of our lives, be aware that important scientific evidence is further confirming the following:

1. The vaccine is neither preventing transmission or infection, nor some serious outcomes, as illustrated in real world public health data from England, Scotland, Israel and Sweden for example, and in contrast to NZ's "reasonably robust modelling" which claims a frankly ludicrous immunity via the vaccines. PHS data shows 9 out of 10 covid deaths now are in the fully vaccinated in their most recent release.<https://dailyexpose.uk/2021/12/09/distracted-by-christmas-party-data-shows-9-in-10-covid-deaths-vaccinated/>
2. All passive vaccine injury reporting systems *seriously under-report*, rated conservatively at 20-40x. So far unrefuted stats put the US death toll at 150,000, so pro rata we could have easily 1000+ deaths in NZ.
3. Many children will die to save a single life with the vaccine, mostly from myocarditis.
4. Heavily vaccinated countries are seeing both huge numbers of new positive PCR tests, and extremely disturbing rises in all-cause deaths (non-covid) in the vaccinated, which now include children as they join in the rollouts.
5. Early treatment with safe existing drugs continues to save lives, whilst being increasingly withheld from the public, as commerce continues to trump compassion. Whilst conscientious doctors trying to import these medicines for their at-risk patients are being referred for investigation, some of our leader-doctors have sold away their oaths (and souls) as point people for the pharmaceutical companies,
6. The vast range of consequences from diffuse microvascular injury and thrombosis (with inevitable cell death beyond the tiny blocked blood vessels) following mRNA injection explains the multiple clinical presentations of harm that seem to be confusing many doctors. This allows them to follow the 'guidance' from the Medical Council, such that even the *possibility* of vaccine injury is not being noted in the differential diagnosis. MCNZ et al. have destroyed clinical medicine. Data released from Pfizer's own early FDA submission speaks to the vast array of conditions seen after the rollout began. All this information is very easy to find for those who are concerned and interested, but genuine researchers will come across censorship very quickly on the usual platforms.

A high-level US government source warned us several months ago that, amongst other dire predictions, **3 monthly indefinite boosters were planned for the world**. We were not shocked therefore to hear the UK Home Secretary announce exactly this to the British population last week. This is in spite of the double-jab immunity already failing, the exponential increase in likely harm with each booster (zero trials have been done), and the 'omicron variant' providing the marvellous potential for rapid worldwide natural immunity to all variants with a seemingly very mild clinical illness in most people. Moderna and Novavax CEO's have both stated the current vaccines won't work against omicron anyway, with Moderna's stating a 3-dose course will be required for immunity.

It is hard to remain dispassionate in this situation, as our world sees the guiding principles of participatory democracy being snuffed out, but we appeal to you, our fellow public servants, to learn and resist the big picture Agenda being foisted upon New Zealand, and to do the right thing, whilst you can still be thanked for doing so. To those immune to any sort of appeal like this, Nuremburg NZ is already in planning.
