



Open Letter to MPs and All Relevant Responsible Government Agencies and Media

Monday 8 November 2021

Dear elected representatives and unelected bureaucrats and press,

NOW CHILDREN TOO ARE **DYING** AND STILL NO-ONE IS ACTING!

Summary:

1. The vaccine has killed and maimed children 11 years + already
2. In many countries, the vaccinated are the bulk of covid-19 deaths and hospitalisations.
3. Early treatment with safe and effective repurposed medicines saves lives and is being denied in NZ.
4. Evidence for lockdowns and mandates is lacking.
5. Cruelty and apartheid are now a feature of NZ life.
6. Evidence emerges of poor data quality in Pfizer trials, and batch mortality differences.
7. Criminal and civil prosecutions are pending.
8. Many people are suffering from an induced trance state called mass formation.

As the UK reports that 85% of its covid deaths are double vaxxed, and child deaths rise 63% since they started receiving their vaccines, we write again with urgency and high concern that our institutions and parliament are captured and failing the New Zealand public regarding our covid-19 vaccine roll-out.

As we roll-out an apartheid society, with no supporting evidence-base, it is clear we *are* in the grip of an epidemic – a cold and hard-hearted virus, infecting people from the top downwards.

If you read nothing else, please just look at the section near the end on **mass formation**. It may help you understand the consequences of the unique circumstances visited on us all.

Since, by your assent to the pandemic response, you are clearly in favour of experimenting on our children, who do not pose a risk to granny, let's look at how that is going.

Recently, a 12-year-old girl became breathless a week after her Pfizer vaccine. Her doctor diagnosed asthma though she had never had this before. At school camp, she worsened and died suddenly in the arms of a camp helper, who - unfortunately for you - was close friends with a worker on 'the people's database', a citizens initiative to compensate for the obvious failure of medicine's pharmacovigilance. We say unfortunately as there will be no way this can be dismissed as invented, or as a case of "not enough information".

The family's doctor allegedly refused to lodge a CARM report, saying "it couldn't be the vaccine". **This is a distressingly common response to many injured patients and bereaved families.** It is impossible for doctors to know for sure so soon. We are reminded of the PMs grossly inappropriate statements shortly after the tragic death of Auckland teenager Isabella Alexander, even before the investigation committee could have begun it's detailed and painstaking assessments.

Equally dreadfully, a year 8 boy has just died in his sleep. His suburban school in the capital city has informed his school mates. It's OK though, because apparently, he got his \$20 vaccine voucher the day before.

A 14-year-old has died in Nelson, following a stroke post-vaccine. Because children sometimes get strokes and heart attacks too, you know. Yeah right.

If any of you have suffered the unimaginable torture of the loss of a child, you will appreciate what these families have to endure. If not, you should pray it never happens to you.

There has been a trail of children into hospital with myocarditis, **losing heart muscle they will never regrow.** It has a 5-year survival of about 50%, reflecting the eventual failure of the remaining much overworked muscle cells. There are many more deaths and injuries than this that await investigation and attribution, and that we have been reporting to the government and opposition for months. Young adults Priscilla, Andre, Matt, Liam, Jasmine, Rochelle, Sean and plenty more.... dead and gone. Whistleblowers reporting death clusters in rest homes, with news blackouts and refusal to submit CARM reports of possible vaccine injury. We demand an immediate cessation of the rollout on urgent humanitarian grounds, and out of basic human decency, whilst standard drug trial investigations are carried out. You must demand Medsafe investigates every single death we have reported. Even assessing those under 50 would take at least a year. The CARM system is lagging and under-reports dramatically.

Ethics, legal and other boring stuff

The Human Rights Commission had affirmed that no vaccine should be mandated, and yet the Health and Disability Commission has allowed the breach of almost every single code item in its patient charter. For instance, the very first one affirms and protects the right to informed consent. It makes no exceptions for a forced vaccination against a virus with similar mortality to the 'flu, the scientific references for which we have previously provided to government, and on our website NZDSOS.com.

Similarly, our precious Bill of Rights and even elements of te Tiriti are deemed subservient to the hastily-initiated Covid Response Act, which is unsupported by good evidence.

The consequences of this forced experimental gene transfer technology are playing out for all to see, except the hypnotised and willfully blind. It DOES interfere with the DNA, our code of life, as many have been predicting. This recent research proves the vaccine DOES cause, and worsen, cancer, disabling BRCA1 and p53, two essential DNA repair and cancer protective

You will have been assured we are crazy conspiracy theorists clutching at straws, though no one has come up with a reason why we would risk the things that have come to pass for us. We are not crazy, some of us have been vaccinators our whole lives, and many more doctors are joining us behind the scenes, especially now that your parliament is forcing many citizens to the wall. It seems you are going "all-in" to follow some supranational playbook, given the legislation on digital ID, freedom of speech and digital currency that is happening right now.

The Evidence for Worldwide Vaccine Carnage Continues to Mount

For any new drug, a few tens of deaths (worldwide), temporally related and accepted to be probably caused by the drug, sees the drug abandoned. For covid vaccines, we are looking at many tens of thousands of deaths reported worldwide. To continue the NZ arm of this trial, knowing what you now know, is BEYOND BELIEF, and to hide behind Medsafe's safety committee will not obviate accusations of presiding over a crime against humanity. It is certain that the CARM system is inadequate to provide the apparent reassurance your parliament is claiming for itself. The CDC and FDA in the US have announced that they have "looked into" 18 000 deaths reported post vaccine and concluded **not a single one has related to the vaccine!** Well, apart from these being about 60 times the usual death rate from ALL vaccines in a similar period so something is obviously going on, the process for properly investigating a single clinical trial injury is exhaustive, prolonged, expensive and very expert. Bizarrely, only a handful of autopsies are available from this huge number.





Finally! An ethical medical association chairman, from Japan, and note his comment that Merck's cutting of supply of ivermectin to his country was confirmation that it was working.



0-19	0.0027%	99.9973%
20-29	0.014%	99.9860%
30-39	0.031%	99.9690%
40-49	0.082%	99.9180%
50-59	0.27%	99.7300%
60-69	0.59%	99.4100%
