

**STATEMENT FROM LYNDA WHARTON,
THE HEALTH FORUM NZ
NOVEMBER 2025**



I read this on behalf of Lynda Wharton, founder of The Health Forum NZ

We stand here today in honour of, and in solidarity with, the many New Zealanders whose lives were seriously harmed by Covid injectables in New Zealand.

Those who willingly took a provisionally approved, novel technology product.....but without a genuine informed consent process....

And the many thousands who took two or more Covid injections, unwillingly, and against their better judgement, in order to keep their job and their ability to care for their family.

In November 2021 40% of employed New Zealanders were given a stark ultimatum – submit to compulsory covid injections, or pack all your workplace belonging in a box and leave the premises. As they left the healthcare or education premises, many were also told that if they returned tomorrow, they would be legally trespassed from the property.

The Medical Exemption system supposedly in place to ensure New Zealanders with legitimate medical grounds, would be exempted from these mandates, was a cruel abject failure. Virtually no one with legitimate grounds, qualified for a medical exemption...not even those who were injured by dose 1. If they were lucky they were given a temporary exemption for 12 weeks to supposedly allow recovery from their vaccine injury before taken the second compelled dose of the very product that harmed them...in order to keep their job.

At the very same time that Pfizer themselves stated that an allergy to ingredients was a contraindication for use...the New Zealand government mandated people with a known allergy to the ingredient PEG, to take the next dose, but this time, in a hospital with a crash cart and a resuscitation team.

At the Health Forum we received literally thousands of emails from the victims of the medical mandate system. 2,000 of their stories were submitted to the

Human Rights Commissioner, in person, during a meeting in early 2022. The same distressing emails were then also submitted to the NZ Royal Commission of Inquiry in November 2025. Now we wait until February 2026 to see the findings of the Royal Commission. A heartless “whitewash” or an unexpected factually accurate tome of history, detailing deception, obfuscation and gaslighting at the highest levels?

Many of those who lost their jobs through vaccine mandates, have never returned to their vocations....too wounded and disillusioned to continue in their profession, instead turning to wildly different lifestyles or jobs. For some, in retrospect, the mandates and job loss turned into a “blessing in disguise”....but for most, the wounds run deep and wide, and trauma and pain remains.

On our active social media platforms we sometimes see passers by admonishing us for still writing about the Covid years. Instead, we should all just “move on”, they say.

Almost 5 years after the first roll out of the Pfizer mRNA in New Zealand, there are many thousands of Kiwi’s who would give anything to be able to just “move on”....but broken heart, minds, and bodies, along with ongoing financial hardships, serve as a daily reminder of the personal cost they continue to pay. The cost of rolling up a sleeve, taking the Pfizer mRNA, and then watching their world fall apart.

I speak of course, of the silent and silenced New Zealanders who were physically harmed by their Covid injections....and the many others who continue to grieve loved ones who passed away suddenly and unexpectedly in the hours, days, weeks or months after their Pfizer.

They join the global family of Covid vaccine harmed. A family the size of which we cannot fathom. With voluntary pharmacovigilance reporting systems, with between 1% and 5% of ACTUAL adverse events ever reported...the numbers are still breathtakingly high.

68,000 Covid injection adverse even reports in New Zealand including nearly 200 post vaccination deaths reported – Medsafe acknowledges a likely 5% of actual events are reported to them.

UK pharmacovigilance systems have received 496,000 reports, encompassing 1.6 million individual adverse events. 370,405 marked SERIOUS.

Serious events are those which lead to hospitalisations, significant medical events and/or permanent injury.

In America, over one million adverse event reports have been filed...including 19,480 post vaccine DEATHS.

For many of those injured or bereaved from around the world, just like the New Zealanders we remember today....Covid will never be "over". Instead they will carry with them physical disabilities, or a broken heart.

I want to close by sharing a part of a recent social media post written by Lynda.

Quote:

Nearly 5 years after the start of the madness, I sometimes despair that so many remain entrenched in ignorance and JUDGEMENT

I see it in our threads constantly, and it always disturbs me.

The vaccinated and the unvaccinated who remain scornful and dismissive of the mRNA injured.

Those who chose not to take the injection and heap scorn on the injured who did take it....gaslighting them with "you had a choice".

And I wish upon wish that somehow I could impart, in just a few words, the many 1000's of stories our followers have personally shared with me.

Their agonies (both physical and emotional). Their unique, complex personal circumstances driving their decision in one direction or the other....feeling trapped, pressured, coerced, manipulated and powerless to make a different decision.

The painful consequences they lived with.

Physical injury from the product

other way.

The loss of job, profession, money, mana, security, homes, marriages and more....faced by those who refused to comply and lost everything in the name of a still experimental injection.

Nobody is coming to fix the suffering and the separation and division.

Only YOU can do that. You and me and us.

We do it by choosing the higher road...over and over and over again.

We do it by choosing compassion and care instead of judgement and aspersion.

We do it by reaching out with a kind word or an act of service...leaning in towards someone who is hurting....whatever decisions they made during the warfare of Covid.

We do it by first and foremost cultivating our humanity and our ever present awareness that "there but for the grace of God go I".

Only by finding (and forgiving) each other once more, will we unite in solidarity and sincerity, to weather the certain tide of change that lays before humanity as a whole.

We are each other's best hope.
